Remembrance of Things Past

A Resident Doll & Toy Show

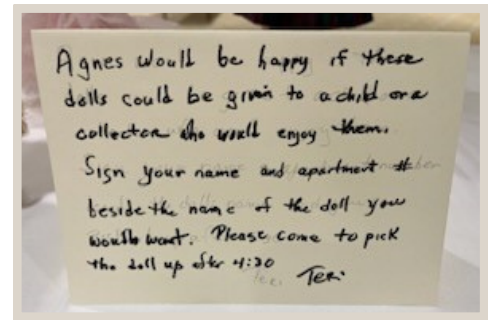
One of the few books I kept from college days was the first volume of Marcel Proust's "Remembrance of Things Past." I know I enjoyed reading it and perhaps I planned to read it again, but I never did, just keeping it for decades from move to move. One theme was the persistence of involuntary memory- which we all have, if we're aware of it or not. Proust wants us to know that memory can shape and nurture us, as well as cause sadness and regret. What possible meaning this concept could have had for me then, a person in her 20s, I don't know, but it sure does resonate now.

Memory, nostalgia, reminiscence and more were on display in Life Engagement's recent Doll & Toy Show. Residents were asked to bring keepsakes that stirred for them feelings of nostalgia and remembrance. And in the items came! Displayed were books, craft items, postcards, boxes, seasonal decorations, photographs, figurines, boats in bottles, toys galore, and of course, dolls [one in a swing, one in a cradle]. Although many decades were represented, the 40s and 50s predominated. Residents did a great job sharing the treasure troves in their basements, attics and storage spaces.

Teri Kuhs warmly hosted one of the exhibits, which consisted of 13 dolls once owned by her late sister Agnes. Agnes lived in Still Hopes until her passing earlier this year and was always lovingly cared for by her family. Agnes lived a full life, worked and travelled, but was not able to live independently. Her doll collection reflected her interests and stages in life. Some dolls had already been given to nieces and nephews and Teri kept two herself which were especially meaningful to her. She decided in Agnes' honor to pass on to others at the show the remainder of the collection. "It all came together," Teri comments, as each of the 13 dolls was

claimed by a Still Hopes resident. Sara Andrews took the doll named Sara, which she then gave to her great-grand daughter- yes, Sara.

Another exhibitor, Jim Newcomb, also honored a sibling- his late brother Dennis who, like Agnes, had some special needs and many amazing strengths. Dennis is

described by Jim as “the child who never grew up.” He always lived with family and pursued passionately his many interests, including learning how to play a number of instruments on his own. Visiting Jim's table one saw belt buckles and leather crafting equipment, comic books, a pinball machine that still works, a slinky, board games, an erector set [complete with instruction book], which Jim says he and Dennis “almost wore out,” many electric toys, a complete cast iron John Deere set, a doll his mother owned and many DINKY brand toys- all metal and to scale. Many items were in their original boxes and still can be played with. Jim loved Dennis dearly and while some of his brother's belongings have been passed down to family over the years, Jim retains many and isn't sure of their future. But he was glad to share them and his brother's memory with the Still Hopes community.

A doll, an erector set, a book - of all things- about memory. Such is the stuff of our youth and our connections to family. That these mundane items can evoke such powerful emotions is testament to our stories and how our childhoods are still with us, no matter our age. Life Engagement's Doll & Toy Show proved a successful vehicle to encourage us to reflect on our pasts- and never stop loving those we shared it with.

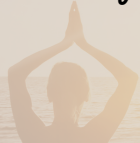

STEWARDSHIP

IRA Required Minimum Distributions



Owners of an Individual Retirement Account, otherwise known as an IRA, know that an account holder aged 73 or older is required by law to withdraw a minimum amount each year. This is called the Required Minimum Distribution (RMD).

Did you also know that your RMD can provide a tax advantage while helping to grow your philanthropic giving?

John Moorman, Principal at Anchor Investments, offers, "We often help clients with "QCD's". These qualified charitable gifts are a win-win. Your chosen charity benefits from a nice gift and you, the account owner, avoid taxes from the normal distribution."

He goes on to explain, "Tax rules have changed greatly in the last few years and deductions are harder to use. By using your IRA, the tax avoidance shows up in keeping your income lower, which can mean lower tax rates. The lower income may translate into lower Medicare costs as well. If you plan to give to a charity, we find using the IRA can be one of the best vehicles to make your gift a win-win."

For 2024, up to \$105,000 of your distribution from an IRA can be a Qualified Charitable Distribution for tax purposes. An accountant or financial advisor can help you with the process. You will start by confirming that your retirement account requires minimum distribution, then calculate your minimum distribution, plan your withdrawal, and determine how much of that withdrawal you would like to give. As you prepare your tax return, be sure to include your donation on relevant tax documents.

Of course, we at Still Hopes welcome gifts from IRA Required Minimum Distributions and can direct them to any of our funds including Resident Assistance, Employee Assistance, Chaplain's Discretionary, Opportunity, Unrestricted, or to support a special project. We accept checks and digital fund transfers. Please ask that your banker include notation your gift to my attention and noting which fund(s) you'd like to donate your gift to.

As we wrap up 2024, consider the tax benefits of gifting your IRA Required Minimum Distribution.
